

AMENDED AND RESTATED ARTICLES  
OF INCORPORATION OF CRESCENT  
CITY RADIO CONTROL CLUB

UNITED STATES OF AMERICA  
STATE OF LOUISIANA  
PARISH OF ORLEANS

I.

The name of the corporation is CRESCENT CITY RADIO CONTROL CLUB, INCORPORATED.

II.

The Corporation is formed for the following purposes:

(a) To provide an organization for individuals who have a common interest and mutual enjoyment in the designing, construction, operation and flying of model aircraft and airplanes of all types; more particularly, but not exclusively, the designing, construction, operation and flying of model aircraft and airplanes by means of remote radio control;

(b) To conduct such other lawful activities as may be consistent with the purposes of the corporation and its members; provided, however, that the corporation shall have no power to engage in business, or perform any such act or acts as may disqualify the corporation from being considered an exempt organization within the meaning of Section 501(c)(7) of the Internal Revenue Code of 1954, as such may from time to time be amended.

III.

The Corporation shall be a non-profit corporation and shall be formed pursuant to the non-profit corporation law of Louisiana. R.S. 12:201 et seq. No part of the net earnings of the Corporation shall inure to the benefit of any member, and, in the event of liquidation none of the assets shall be distributed to any member.

IV.

The location and address of the registered office of the corporation shall be 8601 Steamboat Lane, River Ridge, Louisiana 70123.)

V.

The full names and addresses of the registered agents of the corporation shall be:

VI.

The Corporation is organized on a non-stock basis. Any person, regardless of race, color, creed, sex or national origin, is eligible for membership in this corporation provided such person demonstrates a genuine interest in radio control flying. The members of the Corporation shall consist of six classes, designated as Senior Member, Junior Member, Lifetime Member, Honorary Member, Inactive Member and Delinquent Member. The qualifications of the various classes, designations, voting powers and other rights or privileges, restrictions or limitations are as follows:

(a) Senior Members –

(1) Any member who is 18 years of age or older and who is current in paying his dues is a Senior Member in good standing.

(2) Each Senior Member shall be entitled to one vote and shall be subject to the same restrictions and qualifications.

(b) Junior Members –

(1) Only those persons who are below the age of 18 years shall be eligible for Junior Membership.

(2) A Junior Member shall not be required to pay dues.

(3) A Junior Member shall be sponsored by a Senior Member or Lifetime Member.

(4) A Junior Member shall not be entitled to vote.

(5) Upon reaching one's 18<sup>th</sup> birthday, a Junior Member may be enrolled as a Senior Member without having to pay the usual initiation fee.

(6) A Junior Member shall not be entitled to fly at the Corporation's flying field without the sponsoring member being present at the site.

(c) Lifetime Member –

(1) Only those members who have performed extraordinary services in promoting the goals and purposes of the corporation may be nominated for a Life Membership.

(2) A Life Member shall be elected from among the Senior Members of this organization by a unanimous vote of the quorum present at any duly convened membership meeting.

(3) A Lifetime Member is exempt from paying any dues whatsoever.

(4) A Lifetime Member is entitled to one vote.

(d) Honorary Member –

(1) Persons who have encouraged, cultivated, stimulated and fostered the art and enjoyment of model building and operating to an extraordinary degree shall be eligible to receive an Honorary Membership.

(2) A Honorary Member shall not be entitled to vote.

(e) Inactive Member –

(1) There shall be two categories of Inactive Members:

(i) Senior Members who notify the Executive Committee in advance of February 1<sup>st</sup> of their inability to pay dues because of personal reasons will not be considered delinquent, if approved, and classified as an Inactive Member, Senior Membership status may be resumed by payment of current dues.

(ii) Any Senior Member who moves outside the Metropolitan New Orleans area shall be relieved from all obligations and duties incident to membership in this corporation. Upon the return of such member to the Metropolitan New Orleans area, Senior Membership status may be resumed by payment of current dues.

(2) Inactive Members will cease to be entitled to any rights and privileges incident to membership of this Corporation, including, but not limited to, the right to vote.

(f) Delinquent Member –

(1) Any member who fails to pay his dues, fines, assessments or fees before February 1<sup>st</sup> shall be designated as a Delinquent Member.

(2) A Delinquent Member shall cease to be entitled to any of the rights and privileges incident to membership of this corporation, including, but

not limited to, the right to vote. At such time a Delinquent Member shall be stricken from the membership rolls.

VII.

Loss of membership by forfeiture, suspension, or otherwise shall terminate all interests, rights and privileges of such member in the Corporation, its activities and assets.
