CCRC Club Safety Rules

CCRC Flying Field Requirements

As a new prospecting club member we would like to welcome you and assist you in a safe and enjoyable experience at our CCRC radio control model airplane flying facility.

- (1) Please observe 5 ½ mph speed limit at all times

Note: our facility is located on an active, Sugar - Cane Farm, for your safety please be observant of moving farm equipment, for the farm equipment has the right of way at all times

When entering the farm facility at River Road, please stay on road- Right of Barn/ Office and please observe our 5 ½ mph speed limit.

- (2) **NO RC FLYING:** When grass cutting is in progress for the personal safety of the Lawn Mower Operator

NO RC FLYING: During active FULL SCALE/CROP-DUSTER AIRCRAFT flight operation

NO RC FLYING: At land owner request verbal or posted

NO RC FLYING: No flying over the Pit-Area

- (3) Please pick-up all trash and close and lock all club house doors after use
- (4) For your safety: Please use provided Frequency Pin. On 72 MHz and post your AMA Card on Club House Frequency Control Board

For your safety: Please have model restrain before starting engine and no one facing or adjacent to the propeller arc.

For your safety: When adjusting engine high speed needle valve only behind propeller arc.

For your safety: Please use throttle fail-safe to lower throttle setting. To prevent potential engine run-away during radio signal disruption.

For your safety: Only one pilot per safety gate for RC Flying. We have a total of (6) six safety gates

For your safety: Please announce when landing and runway clear before commencing

- (5) For your safety and others, **(BEFORE EACH MODEL AIRCRAFT FLIGHT)** you need to check and monitor (TX) Transmitter and (RX) Receiver electrical power voltage and battery capacity under load condition with (ESVM) Expanded Scale Voltage Metter or other such electronic device. Please understand the loss of electrical power or low voltage signal may cause a catastrophic event **(NO CONTROL OF MODEL AIRCRAFT)** and has the potential for property damage and personnel injury or death.
- (6) CCRCC Windshield Club Decal:
- A club windshield decal to be displayed at all times (at land owner request) will be provided to all general members in good standing with current AMA License.
- A temporary CCRC Plaket windshield **with expiration date** for new prospective probation member will be provided.
- (7) Prospective member please schedule your flying activity with your sponsor member for this probation period.

From the Staff/Board: Please remember the use of our flying facility is at the Land Owner Pleasure and can be revoke at any time. With this in mind please fly in a safe manner.
